**1.0 NGIMNA (PURPOSE)**

OU Medicine, Inc. Hih policy in sumpiak anei vetlo tepen leibatsik ECAs (Extraordinary Collection Actions) cih tetawh sumngetna bawlding pulak hi. Hih policy leh Sumvai Huhna Thukhun (Financial Assistance Policy) cihtepen OU Medicine panin sumluttawh kisai zuihding thukhun "Internal Revenue Code section 501(r)" leh akisaikha state, federal laws and regulations thukhun cihtetawh kituakin akibawl ahihi.

OU Medicine panin insurance anei ahi zongin, aneilo ahi zongin cina te'n sum apiakding akisamte apiaktheih nading panpih in, cina te tungah sumlakzia leh kaihkhopzia te kibat sakdet nading ki sem hi.

**3.0 GENCIANNA (DEFINITIONS)**

- 3.1 **"Ngettheih hunsung (Application Period)"** cihpen mikhatpeuh in sumvai huhna a ngettheih hunsung cihna ahihi. Hih ngettheih hunpen OU Medicine panin amasapen sumbei lahna (billing statement) akhakkhiat khitzawh (mail ahih keileh email tawhzong khakthei) ni 240 acinni lianin ngettheihhun beihi. Ahi zongin OU Medicine panin vaituamtuan hangtawh ahun sottohei uhhi.
- 3.2 **Phalna tawh asemthei te (Authorized Vendors)"** cihpen OU Medicine tawh thukimna contract abawl te hi uha, hihte'n cina te tungah asum piakzahding uh lai khakthei, theihsakna, sumbeizah lahna cihte khakthei uhhi. Cina te'n sum apiakloh aomleh cina tetawh kithuzak nadingin kizopna bawlthei uhhi.
- 3.3 **"Sumpiakding leibasikna (Extraordinary Collection Action)"** ECA cihpen OU Medicine te'n OU Medicine ii Sumvai Huhna Thukhun (Financial Assistance Policy) tungtawn in mikhatpeuh ii zatui kibawlna sumpiakding te kaihkhopzia, leibasikzia hi a, anuai ateng kihelthei hi: (a) mikhat ii leiba pen adang kipawlna khatah zuaksawn, federal law pan aki pulakte lobuang (b) mikhat ii thu akisamteng credit bureau te tungah puaksawn (c) pawlkhat sepzia tepen federal law tungtawnin upadi tawh sepding kisam, tuatepen apongvan akipia te, bank te khutsung atung innmun te, aki matsak vankhatpeuh, thukibawl aomte, matsakding in thu akipia te, mikhat ii nitha pan sum katsak cihte. Leibasik (ECAs) sungah zato pan kibawlna hangin liamna angah mikhatpeuh (ahihi keileh ama taangmi asem) te tungah state law tawh kizui in thukhenna, daihsakna, lemtuahna tungtawn in akingah apongvan kipia te kihello hi.
- 3.4 **"Sumvai Huhna Thukhun (Financial Assistance Policy)"** Sumvai Huhngetna FAP cihpen OU Medicine panin abawkhiat policy tungtawn in piakding akilawm cina te huhnasum piakna, adiakdiak in OU Medicine FAP sumtawh huhna ahihi.
- 3.5 **"Sumluttawh kisai zuihding thukhun (Internal Revenue Code Section 501(r))"** sungah citpiakna tawh aki vaihawm zato te zuihding thukhunte kihel hi.
- 3.6 **"Zatui vaitawh kep akulte (Medically Necessary Care)"** cihpen cidamna lamsang sepnah anuai a thutetawh akituak te ahihi. (i) anatna, athuakzia leh zatui akibawlzia, alungsim natna cihte tungtawn in siavuan te'n hoihtak kepding in thu apiakte (ii) alungsim cidamlo ahih keileh zatui tawh bawlkul cih natna muhkhiatna omkhin in, hoihtak kepding akulte (iii) zatui tawh kikem, lungsim cidamlo te kepna ah hoihtak kikem in cidamna lamsang sepzia tawh kituak in akikem te (iv) cina leh akemte adingin nopthuapthu ahilo te (v) muanhuaik in sepsakding akisam penpen te, hoihtak kepding in akisam penpente

- 3.7 “Telbaihding atomin (Plain Language Summary)” cihpen Sumvai Huhngetna te asim baihding, telbaihding leh zattangzangding in atomin akibawl ahhi.

**4.0 NASEP SILBAWLZIA (PROCEDURE)**

- 4.1 OU Medicine panin leibasik (ECAs) nasepna ah direct in ahi zongin, kizoppih phalna tawh asemthei (Authorized Vendors) te tungtawn in ahi zongin kihel loding hi. OU Medicine Sumvai Huhna Thukhun (Financial Assistance Policy) nuai panin huhna piaktheihding khentatna aom matengin bangmah ki sawhkhakna kinei loding hi.
- 4.2 Zato kilah ciangin omna address akician in piakding leh telephone nambat te amantak in piakding pen cina ahih keileh sumbei apiading te ii mawhpuaak ahihi. Ciaptehna sungah address kician leh telephone nambat akician aomkeileh hanciamna te amawkna suaksakding hi.
- 4.3 Insurance anei cina tepen insurance company tetawh amasa in (initial claim) bawlmasak kulding hi. Tuakhitzawh anihna leh akisamlai cihte pen OU Medicine ahih keileh phalna tawh asemthei (Authorized Vendors) te'n cinapen taangin ngetna bawlsakthei hi. Tuapen amasapen anget angahkhit ciang hiding hi. Insurance aneilo cina tepen OU Medicine panin sumbei angetzah abeizah te direct in piakding ahihi.
- 4.4 Amasa leh anihna claim ngetna te asiankhit ciangin Insurance anei hiltaleh, aneilo hitaleh avekin OU Medicine panin cina tungtawn in sumbei piakdingte apiakzia pen kibangding hi.
- 4.4.1 OU Medicine ahih keileh phalna tawh asemthei tepen amasapen sumbei lahna (billing statement) aki piakkhitzawh ni 121 acin matengin leibasikna ah kihel loding hi. Cina penin Sumvai Huhna Thukhun (Financial Assistance Policy) nuai ah Sumvai Huhngetna angah theidiam cih hanciamna akineih matengin aki hellodung ahihi.
- 4.4.2 OU Medicine ahih keileh phalna tawh asemthei te'n cina te tungah sumbei lahna (4) te laikhak tawh puakding uh a, tuasung ah Sumvai Huhngetna vaizong kihelding hi. OU Medicine ahih keileh phalna tawh asemthei te'n cina te atawmpen (1) vei peuhmah phone hongsamding uh a, Sumvai Hungetna vai honggending uhhi.
- 4.4.3 Leibasikna akipatma atawmpen ni (30) sungin OU Medicine ahih keileh Authorized Vendors te'n:
- 4.4.3.1 Cina te tungah leibasikding vai zaksak kawmin, OU Medicine te'n zatui kibawlna sumbeite ngetna kipanding cih theihsakna hongneiding uhhi.
- 4.4.3.2 Cina te'n Sumvai Huhngetna vai theihbaihding hilhcianna (Plain Language Summary) hongpiading uhhi.
- 4.4.3.3 Anunung penpen akep uh telephone nambat tungtawn in cina te kamtawh hopih hongsawmding uhhi.
- 4.4.4 Cina te tungah sumvai huhna piaktheih vaite hanciam in hongki zaksak khitzawh bangmah sumpiakna aomkeileh OU Medicine ahih keileh phalna tawh asemthei te'n amasapen zato tuahkhit sumbeizah zaksakna (post-discharge billing statement) hongpiak khitzawh ni 121 khit ciangin sumngetna bawlthei khading uhhi.
- 4.4.5 Ngetna bawltheih (Application Period) hunsung in Sumvai Huhngetna (Financial Assistance Application) akimtak in aki ngahleh OU Medicine te'n leibasikna (ECAs) te khawlsakthei hi, tuasung in cina penin thukhun (Financial Assistance Policy) tawh kituak in sumvai huhna ngahhuai hiam cih ngaihsutsak dinghi. Ngetna bawltheih hunsung in Sumvai Huhngetna akimlo in akipuakleh leibasikna
